## Foundation for Strategic Plan for 2018 to 2020:

- UWP prioritizes projects by feasibility (especially with respect to funding), water quality or watershed health benefits, and public awareness.
- UWP will create a technical committee to support board, contractors and partners in project planning and implementation.
- In 2018, UWP will report on past projects, update the community on recent progress, and write grants for future projects.
- The UWP board will create the 2019 work plan in late 2018, and incorporate into staff contracts to facilitate the projects identified in the strategic plan.
- UWP recognizes that flexible and adaptive management is necessary.

- Goal 2) Improve and maintain riverine ecosystem function including in streams and riparian areas
